





The ABF's very own regional BCH was also launched this 2016, during the COP-MOP 8 Side Event. The ABF Regional Portal is the first of its kind in the history of the Cartagena Protocol on Biosafety which allows exclusive regional collaboration among Parties. The website will serve as a common hub for the ABF countries to facilitate information exchange and provide assistance in implementation of their respective National Biosafety Frameworks.

Central and Eastern Europe Biosafety ROADMAP

(2018-2020). Strategic Objective:

To promote and facilitate compliance with the requirements under Article 20 of the Cartagena Protocol on Biosafety

### Component 1. Improving Country Compliance to CPB through BCH

• Registering National and Reference Records in the BCH

- KEY PERFORMANCE INDICATORS:
- increase in National and Reference Records
- For 2018:
  - 3 National Records per country (National wksp)
  - 1 National report

### **Component 2. Capacity Building**

- Establish Training Systems for CPB and BCH Capacity Building
- Use of E-learning platforms to build capacity in biosafety
- Establishment of On-line Forum for CPB and BCH-related topics
- Participation in On-line Forum for CPB and BCH-related topics
- Public Awareness, Education, and Participation (PAEP) Program
